## JOINT STATEMENT OF SUPPORT

# KONEKTADONG PINOY

A Pro-Filipino, Pro-Consumer, Pro-Competition Bill

#### **IUNE 2025**

We, the undersigned organizations, express our full support and call for the immediate enactment of the *Konektadong Pinoy* (Open Access in Data Transmission) bill. We believe this landmark legislation will democratize internet access, which could potentially be this administration's greatest legacy.

We thank and commend President Ferdinand "Bongbong" Marcos, Jr. for his vision and resolute leadership in championing *Konektadong Pinoy*, with his certification of the bill as urgent.

We laud the Senate and the House of Representatives for ratifying the bicameral conference committee report on the proposed *Konektadong Pinoy* Act. We express gratitude to the leadership of both chambers, the bill's authors, the House Committee on Information and Communication Technology, and the Senate Committee on Science and Technology for shepherding the bill through. This crucial step brings us closer to the enactment of this pro-Filipino, pro-consumer, and pro-competition bill, and truly nationwide digital connectivity for all.

The *Konektadong Pinoy* bill enjoys wide support in the Executive Branch. Key government agencies, including the Department of Economy, Planning, and Development (DEPDev); the Department of Information and Communications Technology (DICT); the Philippine Competition Commission (PCC); the Bangko Sentral ng Pilipinas (BSP); and the Commission on Human Rights (CHR) have all expressed support for the bill. Local government leaders recognize the objective of Konektadong Pinoy to narrow the digital divide as essential "to bridge the technological gap, bolster financial inclusion, enhance literacy, and promote economic growth."

Most importantly, *Konektadong Pinoy* is a response to the clamor of citizens and stakeholders from various sectors, who have long been suffering from inaccessible, unreliable, and costly internet services.

In light of the call by certain groups to veto the bill, we would like to reiterate our request to the President to approve *Konektadong Pinoy* and why the Philippines needs this law.

**Pro-Filipino.** Konektadong Pinoy was created to free Filipinos from the shackles of poor internet. The Philippines has been lagging behind on internet connectivity not only in Asia but in the whole world. Latest data shows that 19,000 barangays (or 45.5% of all barangays nationwide) still lack internet access. According to the World Bank, the widening inequality in internet access limits opportunities for Filipinos, making them unequipped for future work, especially digital jobs. The growing digital divide makes e-commerce, e-government, online learning, and AI virtually inaccessible to millions of Filipinos and disadvantaged sectors.

**Pro-Consumer.** Konektadong Pinoy will reduce internet cost, which will have a transformational impact for consumers, as highlighted by the DICT. In 2022, the country was cited as the "most Internet poor" in Southeast Asia, with over 50 million Filipinos not able to afford a basic internet package. Two years later, the Philippines improved but only did better than Laos and Timor-Leste. Konektadong Pinoy will enable smaller providers to build infrastructure and offer internet services in their communities, including GIDAs.

**Pro-Competition.** Konektadong Pinoy is "a decisive step toward dismantling barriers" in the data transmission industry, according to the PCC. Outdated and restrictive laws have made it cumbersome and costly for small players, such as cable operators and community internet service providers, as well as new and emerging players, to build and expand broadband networks. The DEPDev asserts that the lack of competition has resulted in "underinvestment in infrastructure" and "poor service delivery." Konektadong Pinoy will change the status quo by promoting competition and stimulating the market, and encouraging investment even in the rural barangays!

Konektadong Pinoy has been thoroughly vetted by Congress and the Executive. The bill has undergone rigorous scrutiny, almost 10 years of deliberations, and various improvements through three Congresses. The strong backing from key stakeholders, including established and reputable organizations from major sectors–including government, business, ICT industry, consumers, and civil society groups–is proof that the bill is truly responsive to the urgent digital needs of the country.

Konektadong Pinoy aims to accelerate the deployment of digital infrastructure by streamlining the licensing process, promoting infrastructure sharing, and allowing new and smaller players to deliver both wired and wireless connectivity without requiring a legislative franchise, an antiquated requirement not found anywhere else in the world. Congress has already made the bold and brave decision to remove this requirement, a sign that it agrees with your vision of a digitally-powered country. Retaining the legislative franchise—described by numerous studies, including that of the Philippine Institute for Development Studies (PIDS) as a major barrier to entry that stifles innovation and prevents competition—means retaining the status quo and leaving millions of Filipinos behind.

Claims of *Konektadong Pinoy* resulting in security issues are unfounded. The fact is, the bill is the only proposed policy today that requires big and small, local and foreign network providers alike to comply with cybersecurity measures based on internationally recognized standards and as prescribed by the DICT. It mandates a cybersecurity performance audit and makes this a requirement for continuing operation and license renewal. *Konektadong Pinoy* also disallows foreign government-controlled and state-owned enterprises from operating data transmission networks. Finally, the bill requires that national security be taken into consideration in interconnection and access to infrastructure.

We, the 35 signatories to this statement of support, stand ready to contribute to the successful implementation of this historic piece of legislation.







